### 3. Type of allocation of quota places:

The quota place/s is/are allocated to the NOC. The selection of athletes for its allocated quota places is at the discretion of the NOC subject to eligibility requirements.

## C. ATHLETE ELIGIBILITY

### Compliance with the Olympic Charter and other relevant rules

All athletes must respect and comply with the provisions of the Olympic Charter currently in force, including but not limited to Rule 41 (Nationality of Competitors) and Rule 43 (World Anti-Doping Code and the Olympic Movement Code on the Prevention of Manipulation of Competitions).

Only those athletes who respect and comply with the Olympic Charter, the World Anti-Doping Code and the Olympic Movement Code on the Prevention of the Manipulation of Competitions, including the conditions of participation established by the IOC, plus the rules of IBSF, may participate in the Olympic Games Milano Cortina 2026.

### Age requirements

All athletes participating in the Olympic Winter Games Milano Cortina 2026 must fulfil the age requirements as stated in bylaw 8.4 Licenses of the IBSF International Bobsleigh Rules.

### Additional IF eligibility criteria

To be eligible to participate in the Olympic Winter Games Milano Cortina 2026, all athletes must be medically suitable for practising Bobsleigh racing as per the requirements set forth in bylaw 8.4 Licenses of the IBSF International Bobsleigh Rules and possess appropriate and adequate insurance coverage against accidents and third-party civil liability.

- All athletes must possess a valid IBSF International licence.
- Selected pilots must have been participating and ranked in a minimum of eight (8) IBSF races on at least three (3) different tracks by event in the period between 1 October 2024 and 18 January 2026. In addition, the pilot must have been ranked in at least five (5) of the eight (8) above mentioned races on a minimum of two (2) different tracks during the 2025/2026 season by event by 18 January 2026 (23:59 Lausanne time) and must have been ranked among the top 50 in the Men's Bobsleigh IBSF Combined Ranking List or in the Top 40 in the Women's Bobsleigh IBSF Combined Ranking List respectively in the Women's Monobob IBSF Ranking List of the season 2025/2026 by 18 January 2026 (23:59 Lausanne time).

## D. QUALIFICATION PATHWAY

The qualification process takes place via participation in the Federation's competition activity. Qualification is achieved by the 'pilots' results. Pilots obtain a qualification slot for their NOC.

Participation in 2-man competitions counts only for 2-man, while participation in 4-man competitions counts only for 4-man.

Participation in women's Monobob competitions counts only for women's Monobob, while participation in 2-woman competitions counts only for 2-woman.

## HOST COUNTRY PLACES

If the male and female pilots of the Host Country do not qualify via the qualification process set out above, it will still have the right to take part in the following events with:

- one (1) 2-man Bobsleigh crew;
- one (1) 4-man Bobsleigh crew;
- one (1) 2-woman Bobsleigh crew;
- one (1) Women's Monobob.

Only pilots and crew members meeting the eligibility requirements defined in Section C. can be entered. If no pilot can achieve these conditions, the Host Country will have no representative.

## E. CONFIRMATION PROCESS FOR QUOTA PLACES

### CONFIRMATION OF QUOTA PLACES

On 18 January 2026, the IBSF will publish the results on its website (<http://www.ibsf.org>) and inform the respective NOCs of their allocated quota places on 19 January 2026. The NOCs will then have to confirm if they wish to use these quota places by 21 January 2026 (23:59 Lausanne time), as detailed in section **G. Qualification Timeline**.

### CONFIRMATION OF HOST COUNTRY PLACES

The Host Country must confirm in writing to the IBSF by 21 January 2026 (23:59 Lausanne time) the use of its Host Country Places.

## F. REALLOCATION OF UNUSED QUOTA PLACES

### REALLOCATION OF UNUSED QUOTA PLACES

General rules:

1. Exceeding the total amount of quota places for 2-man and 4-man Bobsleigh is not allowed under any circumstances.
2. Exceeding the total amount of quota places for Women's Monobob and 2-woman Bobsleigh is not allowed under any circumstances.
3. Unused quota places in an event cannot be reallocated to another event. For example, unused quota places in the 2-man Bobsleigh cannot be reallocated to the 4-man or 2-woman Bobsleigh cannot be reallocated to the Women's Monobob.



Unused quota places for NOCs can be exceptionally reallocated to an NOC which has not yet received a quota spot. In case this is not possible due to eligibility criteria, the unused quota spot will be assigned to the 1<sup>st</sup> NOC already qualified whereas the maximum number of 3 (three) teams per NOC may not be exceeded.

If there are places still available for reallocation, only eligible NOCs which do not already have a qualified team by the end of the qualification period will be considered.

Among the potential candidates for reallocation, only the highest ranked pilot in the respective IBSF Ranking List will enable his/her NOC to send a crew to fill a reallocation position.

In cases of equal points, the following decision criteria will be applied:

- a) First, the highest points obtained in a single race.
- b) Next, the highest points obtained in the last race before the qualification deadline.

(World Cup points are of higher priority than points obtained in the other race series)

### REALLOCATION OF UNUSED HOST COUNTRY PLACES

Unused Host Country Place(s) will be reallocated to the next highest ranked pilot on the respective IBSF Ranking List as of 18 January 2026.

## H. AP ATHLETES

### AP ATHLETES

Ap alternate athletes are non-competing athletes and are not included within the athlete's quota as described in section **B. Athletes Quota**. More detailed information about access rights and entitlements can be found in the '*Accreditation at the Olympic Games – Detailed Specification*'. Ap alternate athletes can only become competing athletes as per the conditions outlined in the '*IOC/Milano Cortina 2026 Late Athlete Replacement policy*'.

In Bobsleigh competitions, "Ap" alternate athletes (according to the distribution table below) may be part of the crew as a substitute. In principle, the same crew must take part in each run. However, in the event of injury or illness the IOC Late Athlete Replacement Policy is applicable and will be implemented (to be released March 2025). It is possible to apply for a replacement of the members of the crew – except for the pilot – with the approval of the Jury and the IOC.

**Eligibility:** Ap alternate athletes must comply with the same eligibility rules as competing athletes as described in above section **C. Athlete Eligibility**.
