Quota places are allocated to the athlete(s) by name.

## B.4. Participation rights

### Cross-qualification participation rights

- Any athlete who has qualified for an event may also be qualified for another event in Climbing, provided that the max. NOC quota per event per gender is not exceeded.
- An athlete who qualifies in more than one event will only be counted once in the Climbing's total quota allocation, in an event where an NOC confirms quota acceptance. After the athlete secures a confirmed quota place in the event, the subsequent qualification in another event will not be counted towards quota counting, preserving the quota place available for allocation for the eligible athlete in the respective event.
- If an athlete who has gained a cross-qualification withdraws from a confirmed quota place, their participation rights from the other event will also be forfeited subsequently.

## C. ATHLETE ELIGIBILITY

### C.1. Compliance with the Olympic Charter and other relevant rules

All athletes must respect and comply with the provisions of the Olympic Charter currently in force, including but not limited to Rule 41 (Nationality of Competitors) and Rule 43 (World Anti-Doping Code and the Olympic Movement Code on the Prevention of Manipulation of Competitions), as well as the IOC Policy on the Protection of the Female (Women's) Category in Olympic Sport and Guiding Considerations for International Federations and Sports Governing Bodies (the "Policy").

Only those athletes who respect and comply with the Olympic Charter, the Policy, the World Anti-Doping Code and the Olympic Movement Code on the Prevention of the Manipulation of Competitions, the conditions of participation established by the IOC, as well as the rules or policies of World Climbing, may participate in the LA28 Olympic Games.

Athletes that have already a confirmed quota place in an event shall not be able to take part in the qualification pathway of the relevant event, unless stated otherwise under section D.

### C.2. Age requirements

To be eligible to participate in the Olympic Games Los Angeles 2028, athletes must be born in 2011 or earlier, validated by the passport used for Accreditation (ACR) registration.

### C.3. Additional IF Eligibility Criteria

Athletes must also comply with the following criteria:

- Hold a valid international license issued by World Climbing for the Olympic Games year
- Not have been banned from participating in any World Climbing competition during the Olympic Games year.

### **Olympic Qualifier Series 2028**

The Olympic Qualifier Series (OQS) includes three events:

- Event #1 [Location and dates TBC]
- Event #2 [Location and dates TBC]
- Event #3 [Location and dates TBC]

The invitation to the OQS will be released based on the World Climbing 2027 international events results/rankings. The detailed information on participation criteria is outlined in the separate Qualification System document for OQS.

Quota places will be allocated by the Series Ranking at the conclusion of the three events, respecting the maximum quota per gender per NOC.

### **Host Country Places**

If the host country does not qualify the athletes per gender through the qualification pathway outlined in section D. Qualification Pathway, it will be allocated one host country place for each gender, on condition that the athletes meet the eligibility criteria described under section **C. Athlete Eligibility** of this document.

In addition to the Eligibility Criteria, the eligible athletes must have participated at least one of the events mentioned in section **D.** of this document and must be ranked within the top [*ranking to be confirmed*] per gender in the Series Ranking of the **D.1.4. Olympic Qualifier Series.**

### **Universality Places**

Two universality places, one per gender, are made available to eligible NOCs for the LA28 Olympic Games.

On 1 October 2027, the International Olympic Committee (IOC) will invite all eligible NOCs to submit their requests for universality places. The deadline for NOCs to submit their requests is [*deadline to be added*]. The Tripartite Commission will confirm, in writing, the allocation of universality places to the relevant NOCs after the end of the qualification period for the sport concerned.

Detailed information on universality places is contained in the “Games of the XXXIII Olympiad, Los Angeles 2028 - Olympic Games Universality Places – Allocation Procedure and Regulations” document.

The selected athletes shall meet the required eligibility criteria set out under section **C. Athlete Eligibility** of this document. In addition to the Athlete Eligibility, the athletes must qualify for the **D.1.4. Olympic Qualifier Series** and be ranked with the top [*ranking to be confirmed*] per gender in the **Series Ranking of D.1.4.**

## E. CONFIRMATION

### E.1. Confirmation of Qualification Places

World Climbing will publish the results of the event within five days after the last day of the event on [its website](#).

World Climbing will confirm in writing to the NOCs within five days after the last day of each event, or ranking, the quota places they have obtained. The NOCs will then confirm to World Climbing if they wish to confirm or decline these quota places, as detailed in section **G. Qualification Timeline**.

If an allocated quota place is not confirmed by the NOC by the confirmation of quota place deadline, or is declined by the NOC, the quota place will be allocated to the next highest placed eligible athlete, not yet qualified, from the same event/ranking, respecting the maximum quota per gender per NOC.

When cross-qualification of an athlete occurs within the same **D. Qualification Pathway** where multiple events are held, or when more than one **D. Qualification Pathway** takes place close to one another, World Climbing will inform the NOC in writing to confirm the event awarding the quota place and, consequently, which event to be used for the athlete's participation rights subject to quota place acceptance. Quota allocation will follow the chronological order of qualification events, meaning the event where the athlete first qualifies in time will award the quota place. Participation rights in any other subsequent event for which the athlete has also qualified are conditional upon acceptance of the quota place from the first qualified event. If the NOC declines the quota place from the event occurring first in chronological order, World Climbing will confirm in writing, within five days of receiving the NOC's communication, the allocation of the quota place from the event occurring second in chronological order, where the athlete has also qualified.

### E.2. Confirmation of Host Country Places

In case where the host country did not qualify any athletes through the events/rankings outlined in section **D. Qualification Pathway** of this document, World Climbing will send a request in writing to the NOC as outlined in **G. Qualification Timeline**.

World Climbing will ask the NOC if they wish to use the host country place for the eligible athlete(s), applicable per gender, as detailed under section **D.2. Host Country Places**, and the NOC will then confirm to World Climbing if they wish to use such host country place.

## F. REALLOCATION

### F.1. Reallocation of unused Qualification Places

#### For D.1.2. and D.1.4. Pathways

Unused quota place(s) will be reallocated to the next highest placed eligible athlete, not yet qualified, at the respective event where the quota place was obtained, respecting the maximum quota per gender and per NOC.

---

In cases where, but not limited to, the event is cancelled or there are no eligible athletes, the unused quota place(s) will be reallocated to the next highest placed eligible athlete, not yet qualified, at the **D.1.4. Olympic Qualifier Series**, respecting the maximum quota per gender and per NOC.

The reallocation will be implemented according to the timeline in section **G. Qualification Timeline**.

#### **For D.1.1. and D.1.3. Pathway**

Unused quota place(s) will be reallocated to the next highest placed eligible athlete from the relevant continent, not yet qualified, at the respective event where the quota place was obtained, respecting the maximum quota per gender and per NOC.

In cases where, but not limited to, the event is cancelled or there are no eligible athletes, the unused quota place will be reallocated to the next highest placed eligible athlete from the relevant continent, not yet qualified, at the **D.1.4. Olympic Qualifier Series**, respecting the maximum quota per gender and per NOC.

If there are no eligible athletes from the relevant continent at the **D.1.4. Olympic Qualifier Series**, the unused quota place will be reallocated to the next highest placed eligible athlete irrespective of continent, not yet qualified, at the **D.1.4. Olympic Qualifier Series**, respecting the maximum quota per gender per NOC.

#### **For cross-qualification**

In case where an athlete eligible for a reallocated quota place already holds a confirmed quota place in another event, the athlete may only obtain cross-qualification participation rights and will not receive an additional quota place. World Climbing will confirm in writing to the relevant NOC to accept or decline the athlete's participation rights in the respective event, and the quota place will be reallocated to the next highest-placed eligible athlete, not yet qualified, respecting the maximum quota per gender and per NOC.

The reallocation will be implemented according to the timeline expressed in section **G. Qualification Timeline**.

### **F.2. Reallocation of unused Host Country Places**

Unused host country places will be reallocated to the next highest placed eligible athlete, not yet qualified, at the **D.1.4. Olympic Qualifier Series**, respecting the maximum quota per gender and per NOC. The reallocation will be implemented according to the timeline expressed in section **G. Qualification Timeline**.

---

### **F.3. Reallocation of unused Universality Places**

Any unused Universality place(s) will be reallocated to the next highest placed eligible athlete, not yet qualified, at the **D.1.4. Olympic Qualifier Series**, respecting the maximum quota per gender and per NOC. The reallocation will be implemented according to the timeline expressed in section **G. Qualification Timeline**.
